PRODUCT DESCRIPTION : Dried unusual fruit of a small native evergreen tree of southwest China, *Illicium verum*, used for flavouring purposes (spice).

COUNTRY OF ORIGIN : China

INGREDIENTS : Anise star.

CHEMICAL & PHYSICAL PROPERTIES :

Appearance: A star-shaped, dark brown-orange pod that contains a pea-size brilliant seed in each of its eight segments. It thus forms an eight-pointed star very characteristic. (Visual)

Flavour & Aroma: Pleasant, licorice like odour and taste, closely resembles anise in flavor but stronger. (Organoleptic)

Added sugars: 0 g/100g

Foreign Material: Free in so far as it is possible by current technical means.
