PRODUCT DESCRIPTION:

Sea Salt Extra Coarse is a food grade, fine-screened, white crystalline sodium chloride manufactured by the natural evaporation of seawater from San Francisco Bay. It is refined by washing with clean saturated brine to remove the surface impurities, drained of excess moisture, dried, and screened to size. The product, being a natural evaporate, may contain occasional minute inclusions of extraneous matter from the crystal-growing environment. This extraneous matter may manifest itself as black specks or as lightly coloured material, none of which is harmful in any way. It is a food grade quality, complying fully with the standards for Sodium Chloride as set in the Food Chemicals Codex.

ADDITIVES:

SEA SALT EXTRA COARSE contains no anticaking or free-flowing additives or conditioners.

ORGANOLEPTIC PROPERTIES:

The product has a characteristic saline taste, and may exhibit a slight halogen odour upon warming.
